Notice of Race

1. Rules

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 [DP] The Port of Ipswich and the Harwich Haven Authority Byelaws also apply.
- 1.3 A boat may not protest another boat for a breach of class rules. This changes RRS 60.1 (a). The penalty for any breach of class rules may, at the discretion of the protest committee, be less than disqualification. This changes RRS 64.2. Competitors should note in particular that use of replica equipment that does not convey a competitive advantage will not normally be penalised.
- 1.4 RRS 77 Identification on Sails does not apply. [DP] Boats shall however display a sail number or other clearly visible marking on their main sail that is distinct from that of any other boat in the same class entered in the event and shall inform the race committee of that sail number or marking when signing on for racing each day.

Eligibility and Entry

- 1.5 This is an open event for all members and non-members.
- 1.6 Donations to Age UK
- 1.7 Handicaps will be determined by the organising authority.
- 1.8 [DP] Competitors under the age of 16 years shall be accompanied by a parent, guardian or someone over 16 years of age acting *in loco parentis* while at the club. The responsible adult shall remain at or near the club and be available to take responsibility for the competitor at all times while the competitor is at the club (including while they are on the water).

Sailing Instructions

- 1.9 Sailing instructions will be available on the club website.

Schedule

- 1.10 Racing is scheduled as below

Venue

- 1.11 Racing will be on the river Orwell.

Courses

- 1.12 Courses are expected to be a mixture of round-the-cans and laid courses (e.g., windward-leeward). Course may be either displayed on the race hut , but if lion used as a committee boat then it will be displayed on lion

Privacy Statement

- 1.13 The personal information you provide to the organising authority will be used to facilitate your participation in this event. If you have agreed to be bound by the Racing Rules of Sailing and the other rules that govern the event (the rules), the legal basis for processing that personal information is contract. If you are not bound by the rules, the legal basis for processing that personal information is legitimate interest. Your personal information will be stored and used in accordance with the organising authority's privacy policy. When required by the rules, personal information may be shared with the RYA, your national authority and/or World Sailing. The results of the event and the outcome of any hearing or appeal may be published.

Risk Statement

- 1.14 Rule 3 of the Racing Rules of Sailing states "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone." Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in this event each competitor agrees and acknowledges that:
- a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
 - b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
 - c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
 - d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
 - e) The provision of a race management team, support boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
 - f) The provision of support boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances; and

- g) It is their responsibility to familiarise themselves with any risks specific to this venue or this event drawn to their attention in any rules and information produced for the venue or event, and to attend any competitor briefing held for this event.

Insurance

- 1.15 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of £5m per incident or the equivalent.

Prizes

- 1.16 As the event is aimed at raising money for charity there is no glassware awarded.
